Applying is as Easy as 1...2...3

Gather

- You will need your Social Security Number and State Student ID (SSID). Your SSID is provided by your public high school.
- Private and homeschool students will be provided a SSID on their funding award letter from the State.

Apply online at <u>cincinnatistate.edu/ccp</u>

 Click "New Applicants" and then "<u>Apply Now</u>" to complete online application. Next step instructions will be emailed to you immediately upon submission of the online appplication.

Authorize

 Complete and submit the CCP Authorization Worksheet and high school transcripts. Be sure to include any test results that may be applied toward eligibility. If required to take the ACCUPLACER test, make arrangements.

Application Timeline

- For OPTIMAL course selection and registration:
 - For Summer Registration: Submit online application & materials by March 1
 - For Fall Registration: Submit online application & materials by May 1
 - For Spring Registration: Submit online application
 & materials by November 1

NOTE: Cincinnati State has rolling admission and therefore, does not have rigid deadlines for application to the CCP program. Public school students <u>must</u> adhere to the deadlines imposed by their district. Private and Homeschool students <u>must</u> refer to the State deadlines for funding application/opportunities.

Placement Testing

- If you have not taken a placement test (ACT, SAT, or Accuplacer) you will be required to do so to be eligible to participate/register for classes.
- Accuplacer can be taken on our Clifton or Middletown campus <u>after</u> you have submitted the online CCP application.
- Details about Accuplacer, including hours of operation & requirements can be found on our <u>Placement Test</u> website.
- Your placement scores will determine your course eligiblity.

Eligibility

Standard Error of Measurement (Effective 2018-2019)

If a prospective CCP student scores below the "Assessment Threshold Score" on an approved assessment exam* but within the "Score Range to be Considered," then the student can still be considered eligible for CCP if he/she also meets one of these criteria:

- Has a 3.0 cumulative GPA or
- Receives a recommendation from school counselor, principal or career-technical advisor
