**ILT:**

- The bell schedule for next school year has been approved (split 4th bell, 3 lunches = old schedule)
- Open House proposal for informal event at beginning of school year
  - This item was tabled
- The district is ending semester exams
  - Walnut will retain them
- AP Exams - they discussed when/how students can leave early
- There is a freeze for positions until enrollment comes up
- May 18th - last meeting of term

**LSDMC:**

- The website was addressed at the last meeting
  - In collaboration with the graphic design class, design of the new website will begin (following completion of the brand)

**Hospitality:**

- Faculty and staff appreciation luncheon coming up 04May2022
  - Food has been ordered from Mazunte and the bill has been paid
  - Quarter zip pullovers for all staff should be ready to distribute the same day

**LOE:**

- Approximately \$101,000 raised for the 2021/2022 school year
  - This slightly exceeds donations for the 2019/2020 and 2020/2021 school years for donations (~95K and 97K, respectively)
- Staff appreciation week donations were approximately \$2,200.
- New chair for LOE needed

**WalnutFest:**

- Raised \$13,600.

- Part sign-ups continue
- Chairperson is needed for this event for next year

### Updates from each area/grade level

#### 7<sup>th</sup>/8<sup>th</sup> grade:

- Twilight ball was a success
  - Going to create/circulate a satisfaction survey (to improve Boogie Bash and Twilight Ball going forward)
  - Trying to reconcile money - check is on its way from the district
- Discussion
  - Need to buy money bag(s) with locks on them
  - Suggestion to make a document on how to handle money (procedures)
  - Suggestion to purchase plastic footlockers to lock decorations
    - Ensure purchased items are used for intended purpose
    - Store in the designated closet (re: gym)
    - Suggestion to buy trees and store them securely
      - Someone will price them and get estimate

#### 9<sup>th</sup> grade:

- Spring Fling Dance was a success
  - Need to find a volunteer to work on this for next year

#### 10<sup>th</sup> grade:

- A Taste of 10.0 was canceled; kids participated in the Spring Fling with the 9<sup>th</sup> grade

#### 11<sup>th</sup> grade:

- Prom was a success with over 800 students in attendance

#### 12<sup>th</sup> grade:

- Senior dinner dance in May (had to be rescheduled due to conflict)

### Theatre:

- The teachers have received half of the schedule E stipends they are due and are expected to receive the other half in June
- Lend Me a Tenor attendance has been light
  - Many conflicts with other performance, dances, etc
- Guys and Dolls Jr, the junior high musical is in May
- Mr. Sherman has requested funds for a sound board and training on the software
  - Theater department's soundboard is ten years out of date
- A lightboard is also needed and the Parent association may be funding, but they might have found funding through alumni foundation

### WHIP:

- While the issue with schedule E compensation has been partially resolved, it is not fully corrected yet

- Teachers have received partial payments, but many received incorrect amounts

**Finance:**

- 2 reports went out (the budget for 2022-2023) has been completed and circulated
- \$199k in the bank
- Net positive position, but there is a \$30-35k expected expenditures for the next 5 weeks
- We will probably break even
- At least one expenditure is being paid for by alumni foundation
- Predicting a 15k surplus next year
- Not enough voting members to vote on the finance report, voting will be on the internet (something will be sent out)
- Welcome to Michele Kay who will take over the treasurer position on 30Jun2022
